### Talking Points

In curbing the spread of COVID-19, the Government is **constantly re-evaluating** the Movement Control Order (PKP) directives especially in states that have recorded a sharp increase in COVID-19 positive cases.

This **ongoing reassessment is guided by an early warning system** - Hotspots Identification for Dynamic Engagement (HIDE), jointly developed by Bank Negara Malaysia (BNM) and the Ministry of Health Malaysia (MOH). This HIDE system enables the Government to take **proactive action** in controlling the spread of the COVID-19 epidemic. The Minister of Science, Technology and Innovation, YB Khairy Jamaluddin has already detailed the HIDE system.

To ensure no confusion, all decisions and announcements on the implementation of PKP in any area or state will be made by the **Federal Government after it is decided in the NSC meeting**.



### Movement Control Order (MCO) in Selangor

- After reviewing the Selangor Government's presentation and referring to the MOH and HIDE data, the National Security Council (NSC) agreed to **implement MCO on 6 of the following 9 districts:**
  - Hulu Langat
  - or Petaling
  - Gombak
  - of Klang
  - or Kuala Langat
  - or Sepang
- MCO for the districts involved will come into effect on **6 May until 17 May 2021.**
- While 3 other districts namely **Kuala Selangor, Sabak Bernam and Hulu Selangor** are still under the **Conditional MCO (CMCO).**
- This decision was made after taking into account the **increase in COVID-19 positive cases and to break the chain of COVID-19 infection.** The state of Selangor has recorded a high number of daily cases since April 20 to May 4, 2021.
- **As such, movement across states and districts in these six districts is not permitted at all, EXCEPT on emergency matters.**
- **Food premises** such as restaurants, food trucks, hawkers and kiosks are **allowed to operate from 6.00 am to 12.00 pm only.**
- **Grocery stores, convenience stores and daily necessities** as well as **pharmacies** are also **allowed to operate from 6.00 am to 10.00 pm.**
- **Petrol stations** are **allowed to operate from 6.00 am to 10.00 pm** however **petrol stations on the highway are allowed to operate 24 hours.**
- In addition, **hospitals, clinics and medical laboratories** can operate **as usual.**
- For daily market operations, farmers' markets, public markets and weekly markets are allowed to operate **from 6.00 am to 2.00 pm.**

- Ramadan bazaars in MCO areas are still allowed to operate according to strict SOPs. However, the decision to continue or close the bazaar operation is subject to the authority of the State Government through the Local Authority (PBT).

#### SOP for Hari Raya Aidilfitri

- NSC also examined the presentation by the Islamic Development Department (JAKIM) on the **SOP for Hari Raya Aidilfitri** which is expected to be celebrated on 13 May 2021.
- For **Takbir Raya in Mosques/Surau**, it is allowed in **MCO, CMCO and RMCO areas** according to the ruling of the state religious authority. However, for **EMCO areas**, it is **NOT ALLOWED**.
- However, the practice of **takbir from house to house** is **NOT ALLOWED** in all areas.
- For **MCO, CMCO and RMCO areas**, **Hari Raya Sunat Prayers are allowed** to take place at the Mosque/Surau, but with the total attendance and participation of men, women and children according to the decision of the state religious authority.
- **Sunat Hari Raya** prayers in mosques/suraus are **NOT ALLOWED** in EMCO areas.
- NSC has also decided that **gatherings after Hari Raya Prayers at Mosques/Suraus, Hari Raya open houses, cemetery visits are not allowed** in MCO and EMCO areas.
- For **CMCO and RMCO areas**, **gatherings after Hari Raya Prayers at mosques and suraus are allowed** but is subjected to the state religious authorities. The Mosque/Surau Committee is **encouraged to prepare food in packages and to be distributed** to the congregation to take home.
- **Ziarah Hari Raya/Hari Raya Visits for MCO** is allowed on **1 SYAWAL ONLY** with the presence of guests **not exceeding 15 people at any one time** according to the size of the house with physical distancing being practiced.
- **Ziarah Hari Raya/Hari Raya Visits for CMCO and RMCO** is allowed on **1 to 3 SYAWAL ONLY**. However, for the CMCO areas, the presence of guests is limited to **20 people** at any one time and according to the size of the house with physical distancing being practiced.



- Meanwhile, for the RMCO area, **Hari Raya gathering is allowed with the presence of guests not exceeding 25 people** at any one time according to the size of the house with physical distancing being practiced.
- In ensuring the spread of this epidemic is controlled, **hosts are encouraged to provide a body temperature scanner, use the QR Code MySejahtera or provide a book to record the name and guests phone numbers.**
- **Graveyard visits is allowed for CMCO and RMCO areas provided the limit does not exceed 6 people per lot/grave plot** and cannot be more than 30 minutes.
- However, grave visits for **MCO and EMCO areas are not allowed.**
- **For PKP Diperketatkan (CMCO) areas, Hari Raya Aidilfitiri celebration are only allowed among family members from the same house. This means that they are not allowed at all visiting and to go out of the house.**
- **Any Hari Raya event/ open house for all areas is not allowed.**

### MySejahtera

- To further strengthen the HIDE system, the Government has decided to make use of the MySejahtera application mandatory in all public places, business premises, offices, mosques and houses of worship. All premises are also required to register with the MySejahtera application.
- Exceptions are given for areas that do not have internet access, especially in remote and rural areas.

### Green Travel Bubble (Gelembung Pelancongan Bersar)

- The government has also decided to SUSPEND APPROVALS for cross-state through the Green Travel Bubble from CMCO-to-CMCO areas for the purpose of tourism using travel agencies with immediate effect.

### Termination of EMCO at Rumah Panjang Matthew, Pakan, Sarikei, Sarawak

- Previously the government had implemented the Enhanced Movement Control Order (EMCO) at Rumah Panjang Matthew, Pakan, Sarikei, Sarawak which is scheduled to end tomorrow 5 May 2021.
- During the period, a total of 16 positive COVID-19 cases were recorded by the Ministry of Health Malaysia (MOH) as a result of a total of 67 screening tests conducted at the longhouse.
- MOH also confirmed that there is a decrease in cases and clusters are under control while the last case was recorded on 26 April 2021 which was 14 cases.
- After conducting a risk assessment with various agencies in the MCO Technical Committee and on the advice of the MOH, the Government agreed to terminate the EMCO at the Rumah Panjang Matthew, Pakan, Sarikei, Sarawak on 5 May 2021, as scheduled.

### Termination of EMCO three (3) housing estates in Lahad Datu, Sabah

- Previously the government had implemented the Enhanced Movement Control Order (EMCO) in three housing estates, namely Taman Aman 3, Taman Aman Jaya and Taman Palm Height, Lahad Datu, Sabah which is scheduled to end tomorrow, 5 May 2021.
- To date, the Ministry of Health Malaysia (MOH) has implemented 174 screening tests in the three areas but only three (3) positive COVID-19 cases were recorded.
- MOH also confirmed that there was a decrease in cases and clusters were under control while all positive cases had received treatment.
- After conducting a risk assessment with various agencies in the MCO Technical Committee and on the advice of the MOH, the Government agreed to terminate the EMCO at Taman Aman 3, Taman Aman Jaya and Taman Palm Height, Lahad Datu, Sabah on 5 May 2021, as scheduled.

### Extension of EMCO at Rumah Panjang Dinggai, Pakan, Sarikei, Sarawak

- Previously the government has implemented the Enhanced Movement Control Order (EMCO) at Rumah Panjang Dinggai, Pakan, Sarikei, Sarawak which is scheduled to end tomorrow 5 May 2021.
- A total of 21 positive cases were recorded as a result of a total of 51 COVID-19 screening tests conducted by the Ministry of Health Malaysia (MOH) in the longhouse.
- MOH also informed that there is still an outbreak of cases among the occupants of the longhouse and there are new cases recorded in the locality.
- After conducting a risk assessment with various agencies in the MCO Technical Committee and on the advice of the MOH, the Government has agreed to extend the EMCO at Rumah Panjang Dinggai, Pakan, Sarikei, Sarawak from 6 May to 19 May 2021.
- The EMCO SOP is the same as previously announced and for more information, please refer to the NSC (MKN) website which is <https://www.mkn.gov.my>

### Compliance Operations Task Force

- The Government has directed the Royal Malaysian Police (PDRM) to increase monitoring of SOP compliance in the states and hotspot areas identified under the HIDE system.
- Enforcement measures by other enforcement agencies will also be enhanced in the field.
- Yesterday, the Compliance Operations Task Force led by PDRM conducted 70,851 inspections to monitor and enforce compliance with MCO SOPs.
- 301 individuals were arrested for SOP default. Of that number, a total of 293 individuals were compounded while another 8 were remanded.
- Among the offenses recorded:
  - Failure to record personal details/check -in premises (127)
  - Not wearing a face mask (70)
  - No physical distancing (19)
  - Others (85)

### National Border Control

- Operation BENTENG (Op BENTENG) yesterday has caught nine (9) Illegal Immigrants (PATI) as well as seized four (4) land vehicles.
- A total of 173 boats/ships were also detected in the waters of the country through 13 observation activities.
- Op BENTENG involves the Royal Malaysian Police (PDRM), Malaysian Armed Forces (ATM), Enforcement Agency, Malaysian Maritime (APMM) and Border Security Agency Malaysia (AKSEM) as well as other security agencies which carried out 280 Roadblocks (SJR) yesterday, namely:
  - Op PENAWAR (ATM, PDRM and RELA) - 224 SJR
  - Op BENTENG PDRM - 47 SJR
  - Op BENTENG AKSEM - 9 SJR

### Public Sanitation Operations

- Last night, a total of 74 sanitation operations were performed covering 36 red zones, 2 orange zones, 6 yellow zones and 5 green zones in the whole country.
- This sanitation operation involved 471 members of the Fire Department and Malaysian Rescue (JBPM) and 102 Authorities Local (PBT) as well as 75 JBPM machines.
- A total of 22,587 sanitation operations covering 156 zones has been conducted since March 30, 2020. Sanitation operations involving business centers, residential areas included People's Housing Project (PPR), public places, supermarkets and government buildings.

## **Mandatory Quarantine**

- Cumulatively, since 24 July 2020, a total of 195,229 individuals have returned to the homeland and all are housed at 73 hotels and nine (9) Public Training Institutes (ILAs) as well Institutes of Private Studies nationwide.
- Of the total, a total of 8,664 individuals were quarantined and 184,757 people were allowed to return while another 1,808 taken to hospital.
- Yesterday, a total of 1,008 individuals arrived at all international entrances and has been quarantined at 36 quarantine stations in the whole country.
- Starting next week, individuals given Home Surveillance Order (HSO) for those who are categorized as meeting contacts will be required to wear surveillance devices for detection purposes.

## **Closing**

Recently, the government has announced temporary sanctions on Indian travelers as well as incoming flights from India to the country to curb the spread of the new variant of COVID-19 from that country.

However, there are still parties who are not responsible by spreading the news that the government is still allowing incoming flights from India to Malaysia.

Many believed about the allegations but in the end, the broadcaster appeared to apologize for the misunderstanding.

With the COVID-19 contagion situation still at a high level, the government would like to remind the public not to spread untrue news that can affect the people and cause anxiety.

This includes its spread on social media, the WhatsApp application etc. regarding the government's stance to implement Movement Control Order (PKP) or 'total lockdown' such as that implemented on 18 March 2020 (MCO 1.0).

I myself receive a lot of WhatsApp posts asking about this. The spreading of news about ‘total lockdown’ is nothing new as it was previously done on all social media and other apps before the government implemented PKP 2.0

I warn people not to take opportunities like this, to grab as much attention, as this may create a sense of panic to the public.

Dalam mengekang penularan COVID-19, Kerajaan **sentiasa menilai semula** arahan Perintah Kawalan Pergerakan (PKP) khususnya di negeri-negeri yang mencatatkan peningkatan kes positif COVID-19 secara mendadak.

Penilaian semula secara berterusan ini **berpandukan sistem amaran awal** - *Hotspots Identification for Dynamic Engagement* (HIDE), yang dibangunkan bersama oleh Bank Negara Malaysia (BNM) dan Kementerian Kesihatan Malaysia (KKM). Sistem HIDE ini membolehkan Kerajaan untuk **mengambil tindakan proaktif** dalam mengawal penularan wabak COVID-19. Menteri Sains, Teknologi dan Inovasi, YB Khairy Jamaluddin telah pun memperincikan sistem HIDE.

Bagi memastikan tiada kekeliruan, segala keputusan dan pengumuman pelaksanaan PKP di mana-mana kawasan ataupun negeri akan **dibuat oleh Kerajaan Persekutuan selepas ia diputuskan dalam sidang mesyuarat MKN**.

## **Perintah Kawalan Pergerakan (PKP) di Selangor**

- Setelah meneliti pembentangan Kerajaan Selangor serta merujuk kepada KKM dan data HIDE, Majlis Keselamatan Negara (MKN) bersetuju untuk **melaksanakan PKP** ke atas **6 daripada 9 daerah** berikut:
  - Hulu Langat
  - Petaling
  - Gombak
  - Klang
  - Kuala Langat
  - Sepang
- PKP bagi daerah yang terlibat akan mula **berkuat kuasa pada 6 Mei sehingga 17 Mei 2021.**
- Manakala 3 lagi daerah iaitu **Kuala Selangor, Sabak Bernam dan Hulu Selangor** masih berada di bawah **PKP Bersyarat (PKPB)**.
- Keputusan ini dibuat setelah mengambil kira **peningkatan mendadak** kes positif COVID-19 dan bagi **memutuskan rantaian jangkitan COVID-19**. Negeri Selangor telah mencatatkan jumlah kes harian yang tinggi sejak 20 April sehingga 4 Mei 2021.

- Dengan itu, pergerakan merentas negeri dan daerah dalam enam daerah ini adalah tidak dibenarkan sama sekali, KECUALI atas urusan kecemasan.
- Premis makanan seperti restoran, *food truck*, penjaja dan kiosk dibenarkan beroperasi dari 6.00 pagi sehingga 12.00 malam sahaja.
- Kedai runcit, serbaneka dan keperluan harian serta farmasi juga dibenarkan beroperasi dari 6.00 pagi sehingga 10.00 malam.
- Stesen minyak dibenarkan beroperasi dari 6.00 pagi sehingga 10.00 malam bagaimanapun stesen minyak di lebuhraya dibenarkan beroperasi 24 jam.
- Selain itu, hospital, klinik dan makmal perubatan boleh beroperasi seperti biasa.
- Untuk operasi pasar harian, pasar tani, pasar awam dan pasar minggu dibenarkan beroperasi dari jam 6.00 pagi hingga 2.00 petang.
- Bazar ramadan di kawasan PKP masih dibenarkan beroperasi mengikut SOP ketat. Walau bagaimanapun, keputusan untuk meneruskan ataupun menutup operasi bazar adalah tertakluk di bawah kuasa Kerajaan Negeri melalui Pihak Berkuasa Tempatan (PBT).

- Bagi mengetahui **SOP lanjut berhubung PKP** di 6 daerah ini, anda boleh mengakses laman sesawang MKN di [WWW.MKN.GOV.MY](http://WWW.MKN.GOV.MY).

### **SOP Hari Raya Aidilfitri**

- MKN turut meneliti pembentangan Jabatan Kemajuan Islam (JAKIM) mengenai **SOP Hari Raya Aidilfitiri** yang dijangka akan disambut pada 13 Mei 2021.
- Bagi **Takbir Raya** di Masjid/Surau, ianya dibenarkan di **kawasan PKP, PKPB dan PKPP** mengikut ketetapan pihak berkuasa agama negeri. Namun begitu, bagi kawasan **PKPD**, ianya **TIDAK DIBENARKAN**.
- Walaubagaimanapun, amalan **takbir dari rumah ke rumah** adalah **TIDAK DIBENARKAN** di semua kawasan.
- Bagi kawasan **PKP, PKPB dan PKPP**, **Solat Sunat Hari Raya dibenarkan berlangsung** di Masjid/Surau, namun dengan jumlah kehadiran serta penyertaan jemaah lelaki, wanita dan kanak-kanak mengikut ketetapan pihak berkuasa agama negeri.
- **Solat Sunat Hari Raya di masjid/surau TIDAK DIBENARKAN** di kawasan **PKPD**.

- MKN juga telah membuat keputusan bahawa **jamuan selepas Solat Hari Raya di Masjid/Surau, rumah terbuka hari raya, ziarah tanah perkuburan** adalah **tidak dibenarkan di kawasan PKP dan PKPD**.
- Bagi kawasan **PKPB dan PKPP, Jamuan Selepas Solat Hari Raya di masjid dan surau dibenarkan** tertakluk kepada pihak berkuasa agama negeri. Jawatankuasa Masjid/Surau digalakkan menyediakan **juadah secara berbungkus** dan diedarkan kepada para jemaah untuk dibawa pulang.
- **Ziarah Hari Raya bagi PKP adalah dibenarkan pada 1 SYAWAL SAHAJA** dengan kehadiran tetamu adalah **tidak melebihi 15 orang pada satu-satu masa** mengikut saiz rumah dengan penjarakan fizikal.
- **Ziarah Hari Raya bagi PKPB dan PKPP adalah dibenarkan pada 1 sehingga 3 SYAWAL SAHAJA.** Namun begitu bagi kawasan PKPB kehadiran tetamu terhad kepada **20 orang pada satu-satu masa** mengikut saiz rumah dengan penjarakan fizikal.
- Manakala, bagi kawasan PKPP **ziarah Hari Raya dibenarkan** dengan kehadiran tetamu **tidak melebihi 25 orang pada satu-satu masa** mengikut saiz rumah dengan penjarakan fizikal.

- Dalam memastikan penularan wabak ini terkawal, tuan rumah **digalakkan** untuk menyediakan **alat pengimbas suhu badan, menggunakan QR Code MySejahtera** atau menyediakan buku bagi mencatatkan nama dan no. telefon tetamu.
- **Ziarah tanah kubur** dibenarkan bagi kawasan PKPB dan PKPP dengan syarat had tidak melebihi **6 orang** bagi satu lot/petak kubur serta tidak lebih daripada **30 minit**.
- Walaubagaimanapun, ziarah tanah kubur bagi **kawasan PKP dan PKPD adalah tidak dibenarkan**.
- Bagi **kawasan PKP Diperketatkan (PKPD)**, sambutan Hari Raya Aidilfitiri hanya dibenarkan dalam kalangan ahli keluarga daripada rumah yang sama sahaja. Ini bermakna mereka tidak dibenarkan sama sekali untuk keluar daripada rumah dan melakukan amalan kunjung mengunjung.
- **Penganjuran sebarang majlis/ rumah terbuka hari raya** bagi semua kawasan adalah **tidak dibenarkan**.

## **MySejahtera**

- Bagi memperkasakan lagi sistem HIDE, Kerajaan telah membuat keputusan untuk **mewajibkan penggunaan aplikasi MySejahtera** di semua tempat awam, premis perniagaan, pejabat, masjid dan rumah-rumah ibadat. Semua premis juga diwajibkan untuk mendaftar dengan aplikasi **MySejahtera**.
- **Pengecualian** diberikan bagi kawasan-kawasan yang **tidak mempunyai capaian internet khususnya di kawasan kampung dan pedalaman.**

## **Gelembung Pelancongan Bersasar**

Kerajaan juga membuat keputusan untuk **MENGGANTUNG KEBENARAN** rentas negeri melalui **Gelembung Pelancongan Bersasar** (Green Travel Bubble) ke kawasan PKPP ke PKPP bagi tujuan pelancongan menggunakan agensi pelancongan berkuat kuasa serta-merta.

## **Penamatan PKPD di Rumah Panjang Matthew, Pakan, Sarikei, Sarawak**

- Kerajaan sebelum ini telah melaksanakan Perintah Kawalan Pergerakan Diperketatkan (PKPD) di Rumah Panjang Matthew, Pakan, Sarikei, Sarawak yang dijadualkan tamat pada esok 5 Mei 2021.
- Dalam tempoh itu, sebanyak **16 kes positif COVID-19 telah direkodkan** oleh Kementerian Kesihatan Malaysia (KKM) hasil daripada keseluruhan **67 ujian saringan** yang dilakukan di rumah panjang tersebut.
- KKM juga mengesahkan terdapat **penurunan kes dan kluster adalah terkawal** manakala kes terakhir telah direkodkan pada **26 April 2021** iaitu **14 kes**.
- Setelah membuat penilaian risiko bersama pelbagai agensi dalam Jawatankuasa Teknikal PKP dan atas nasihat KKM, Kerajaan bersetuju **menamatkan PKPD di Rumah Panjang Matthew, Pakan, Sarikei, Sarawak pada 5 Mei 2021, seperti yang dijadualkan**.

## **Penamatan PKPD tiga (3) taman perumahan di Lahad Datu, Sabah**

- Kerajaan sebelum ini telah melaksanakan Perintah Kawalan Pergerakan Diperketatkan (PKPD) di tiga taman perumahan iaitu **Taman Aman 3, Taman Aman Jaya dan Taman Palm Height, Lahad Datu, Sabah** yang dijadualkan tamat pada esok, 5 Mei 2021.
- Sehingga kini, Kementerian Kesihatan Malaysia (KKM) telah melaksanakan 174 ujian saringan di ketiga-tiga taman tersebut namun hanya **tiga (3) kes positif COVID-19 direkodkan**.
- KKM juga mengesahkan terdapat penurunan kes dan kluster adalah terkawal manakala semua kes positif telah menerima rawatan.
- Setelah membuat penilaian risiko bersama pelbagai agensi dalam Jawatankuasa Teknikal PKP dan atas nasihat KKM, Kerajaan bersetuju **menamatkan PKPD di Taman Aman 3, Taman Aman Jaya dan Taman Palm Height, Lahad Datu, Sabah pada 5 Mei 2021, seperti yang dijadualkan**.

## Pelanjutan PKPD di Rumah Panjang Dinggai, Pakan, Sarikei, Sarawak

- Kerajaan sebelum ini telah melaksanakan Perintah Kawalan Pergerakan Diperketatkan (PKPD) di Rumah Panjang Dinggai, Pakan, Sarikei, Sarawak yang dijadualkan tamat pada esok 5 Mei 2021.
- Sebanyak **21 kes positif** telah direkodkan hasil daripada keseluruhan **51 ujian saringan** COVID-19 yang dilakukan Kementerian Kesihatan Malaysia (KKM) di rumah panjang tersebut.
- KKM juga memaklumkan, masih berlaku penularan kes dalam kalangan penghuni rumah panjang tersebut serta terdapat kes baharu direkodkan di lokaliti itu.
- Setelah membuat penilaian risiko bersama pelbagai agensi dalam Jawatankuasa Teknikal PKP dan atas nasihat KKM, Kerajaan bersetuju **melanjutkan PKPD di Rumah Panjang Dinggai, Pakan, Sarikei, Sarawak bermula 6 Mei sehingga 19 Mei 2021.**
- SOP PKPD sama seperti yang telah diumumkan sebelum ini dan untuk maklumat lanjut, sila rujuk di laman sesawang MKN iaitu <https://www.mkn.gov.my>

## **Task Force Operasi Pematuhan**

- Kerajaan telah mengarahkan Polis Diraja Malaysia (PDRM) supaya **meningkatkan pemantauan pematuhan SOP** di negeri-negeri dan kawasan-kawasan *hotspot* yang dikenalpasti di bawah sistem HIDE.
- Langkah-langkah penguatkuasaan oleh **agensi penguatkuasaan yang lain** juga akan **dipertingkatkan di lapangan**.
- Semalam, Task Force Operasi Pematuhan yang diketuai PDRM telah melakukan **70,851 pemeriksaan** bagi memantau dan menguatkuasakan pematuhan SOP PKP.
- **301 individu ditahan** atas kesalahan ingkar SOP. Daripada jumlah itu, seramai **293 individu dikompaun** manakala **8 lagi direman**.
- Antara kesalahan yang direkodkan:
  - Gagal merekod butiran diri/daftar masuk premis (**127**)
  - Tidak memakai pelitup muka (**70**)
  - Tiada penjarakan fizikal (**19**)
  - Lain-lain (**85**)

## **Kawalan Sempadan Negara**

- Operasi BENTENG (Op BENTENG) semalam telah **menangkap sembilan (9) orang Pendatang Tanpa Izin (PATI)** serta **merampas empat (4) buah kenderaan darat**.
- Sebanyak **173 buah bot/kapal** turut dikesan di perairan negara **melalui 13 aktiviti penglihatan**.
- Op BENTENG melibatkan Polis Diraja Malaysia (PDRM), Angkatan Tentera Malaysia (ATM), Agensi Penguatkuasaan Maritim Malaysia (APMM) dan Agensi Keselamatan Sempadan Malaysia (AKSEM) serta agensi-agensi keselamatan lain turut menjalankan **280 Sekatan Jalan Raya (SJR)** semalam iaitu:
  - Op PENAWAR (ATM, PDRM dan RELA) - **224 SJR**
  - Op BENTENG PDRM - **47 SJR**
  - Op BENTENG AKSEM - **9 SJR**

## **Operasi Sanitasi Awam**

- Semalam, sebanyak **74 operasi sanitasi** dilakukan meliputi **36 zon merah, 2 zon jingga, 6 zon kuning dan 5 zon hijau** di seluruh negara.
- Operasi sanitasi ini melibatkan **471 anggota Jabatan Bomba dan Penyelamat Malaysia (JBPM)** dan **102 Pihak Berkuasa Tempatan (PBT)** serta **75 buah jentera JBPM**.

- Sebanyak **22,587** operasi sanitasi yang merangkumi **156 zon** telah dilakukan sejak **30 Mac 2020**. Operasi sanitasi melibatkan pusat perniagaan, kawasan perumahan termasuk Projek Perumahan Rakyat (PPR), tempat awam, pasar raya dan bangunan kerajaan.

### **Kuarantin Wajib**

- Secara kumulatifnya, sejak 24 Julai 2020, seramai **195,229 individu** telah pulang ke tanah air dan kesemua ditempatkan di **73 hotel dan sembilan (9) Institut Latihan Awam (ILA)** serta Institut Pengajian Swasta di seluruh negara.
- Daripada jumlah itu, seramai **8,664 individu** telah **dikuarantin** dan **184,757 orang dibenarkan pulang** manakala **1,808 lagi dibawa ke hospital**.
- Semalam, seramai **1,008 individu tiba di semua pintu masuk antarabangsa** dan telah dikuarantin di **36 stesen kuarantin** di seluruh negara.
- Bermula minggu hadapan, **individu yang diberi Perintah Pengawasan dan Pemerhatian di Rumah** atau *Home Surveillance Order* (HSO) bagi mereka yang dikategorikan sebagai **kontak rapat** akan **diwajibkan untuk memakai peranti pengawasan** bagi tujuan pengesanan.

## Penutup

Baru-baru ini, kerajaan telah mengumumkan sekatan sementara ke atas pengembara warga India serta penerangan dari India masuk ke negara ini bagi mengekang penularan varian baharu COVID-19 dari negara tersebut.

Namun, masih ada pihak tidak bertanggungjawab dengan menularkan berita kononnya kerajaan masih membenarkan kemasukan penerangan dari India ke Malaysia.

Ramai yang percaya mengenai dakwaan itu namun akhirnya penyebar berkenaan tampil memohon maaf akibat salah faham

Dengan situasi penularan COVID-19 yang masih tinggi, kerajaan ingin mengingatkan orang ramai untuk tidak menyebarkan berita tidak benar yang boleh mempengaruhi rakyat dan sekali gus menimbulkan kegelisahan.

Ini termasuklah penularannya di media sosial, aplikasi WhatsApp dan sebagainya mengenai pendirian kerajaan untuk melaksakan Perintah Kawalan Pergerakan (PKP) atau 'total lockdown' seperti yang mana pelaksanaan PKP 1.0 pada 18 Mac 2020.

Saya sendiri menerima banyak kiriman WhatsApp bertanyakan hal ini. Penularan berita mengenai 'total lockdown' bukan perkara baru kerana ia pernah disebarluaskan di semua media sosial dan aplikasi lain sebelum kerajaan melaksanakan PKP 2.0.

Saya mengingatkan orang ramai supaya tidak mengambil kesempatan seperti ini untuk meraih perhatian kerana ia boleh mendatangkan rasa panik kepada orang ramai.
